Likewise, the objective was to disseminate the advances and results of the scientific and technological research work to the university community and society in general. The event was held on November 26, 27 and 28 this year in parallel rooms by zoom in which the reception of research papers, category Conferences, student papers and scientific articles took place. Likewise, the Diffusion of the INTERNATIONAL CONFERENCE CHALLENGES OF RESEARCH AND INNOVATION IN TIMES OF COVID-VIRTUAL was carried out, via email with invitations to neighboring universities at a national and international level. The papers were presented in three categories: lectures, scientific papers, and student papers.30 national and international lectures, 12 national and international articles by students and 30 national and international scientific papers were presented. The topics developed were: Education in Science, Technology, and Humanities, Health Protection and Struggle against Covid-19, Governance and Public Policies, Environment, Social Development and Development and Economic Growth.
